COVID is still a concern for long term care organizations

In March 2020 Fairlawn closed down all visitation and took significant precautions to prevent the spread of COVID on our campus. Over two years later, we are pleased that visitation is once again allowed and we have many family and friends visiting with residents each day.

In the past 6 months we have been able to relax many restrictions and resume group activities, dining and chapel services. However, we continue to be diligent in monitoring for COVID and ensuring safety precautions are in place to protect the health of our residents.

Over 90% of residents are fully vaccinated and staff continue to wear personal protective equipment such as masks. Unfortunately with the recent uptick in cases in the county, Fairlawn also experienced an outbreak of COVID with 12 residents of the Care Center and 1 assisted living resident impacted. This required a temporary stop to group activities for all and for the COVID positive residents to be quarantined. Staff continue to diligently follow safety protocols.

Per CDC guidelines, affected residents must quarantine for a minimum of 10 days and the facility must have no new cases of COVID for 14 days among residents or staff before group activities can resume. On a positive note, we have been able to continue visitation. One rule change that came about in the last year is that visitation does not need to stop.

Visitors continue to be welcome throughout the campus.
